#### **SUMMARY OF OVERALL EXPERIENCE**


I am Dr Oby Osuchukwu, a HCPC registered and BPS Chartered Counselling Psychologist. In 2016, I was awarded a Doctorate in Counselling Psychology by Roehampton University. Prior to this qualification, I was awarded MSc in Psychology at University of East London in 2012; MDiv in Integrative Counselling by University of Liverpool in 2006, and Higher Diploma in Cognitive Behavioural Therapy by Institute of Counselling, Glasgow in 2007. I have, therefore, been a qualified and, BACP registered psychotherapist for the past 16 years.

I have worked in voluntary, private and public sector organisations in various capacities. I worked for years in the NHS Secondary Psychological services (AMHS) and gained expertise in assessing and providing psychological interventions to adults, and adolescents with attachment issues, Traumas, and high intensity tier 3 and 4 mental health difficulties (e.g., severe Depression, Anxiety, Bipolar, PTSD, OCD, Schizophrenia, and Psychosis. I have experience in using NICE Guideline approved approaches: CBT, DBT, CAT, CFT, ACT etc. to work with these client-groups My primary professional qualification is in Medicine and Surgery (MBBS). During my medical practice, I managed patients with varieties of clinical problems for over ten years. In course of my clinical work, as a physician, I worked as one of the World Health Organisation (WHO) representatives in Nigeria (Abuja) for HIV/AIDS treatment programme — I was actively involved in the treatment and management of HIV/AID patients.

After qualifying as a Psychotherapist, I established my private psychological practice (FCC Clinics) in 2006 where I provide psychological assessments, reports, and/or therapeutic interventions to adults and young people with a wide range of psychological needs. In my current role as a consultant in FCC Clinics, I work with various professionals and organisations (e.g., Insurance companies, Universities, Judiciary, local authorities) to provide therapeutic, medico-legal, as well as supervisory services. In addition to assessment and intervention for clients with fertility, and complex mental health problems, I have developed a community based Cognitive Analytical Therapy (CAT) services for first- and second-generation immigrants and people from BAME community. This service offers these client-groups the opportunity to process their life experiences in relation to stigmas around mental health issues. Our community-based CAT service is also available for couples that are experiencing infertility/subfertility and those undergoing fertility treatment.

I also set up and run group therapy for younger adult males (aged 18 to 25 years) with anger/aggressive issues, and/or mental health history. Some of these young males were ex-offenders and required reintegration back into the community. The aim of the service is to assist with the reintegration of these men back into the community, as well as managing and preventing any risky behaviours they may present while in the community. In addition to my clinical work, I have years of experience in providing medico-legal psychological assessment and reports to individuals, agencies/organisations, local authorities, legal system (courts and solicitors). My medico-legal work in FCC Clinics includes *Personal Injury* (e.g., RTA, Accidents at work/public places), *Family law (public and private)*: e.g., Attachment issues, Domestic Violence, Historical Sexual Abuses, Substance misuse, and/or Mental health difficulties etc). As earlier indicated, I have worked on a variety of cases which were either privately or publicly funded.
