I was responsible for running an outpatient medical clinic, seeing patients from all age groups and with various medical conditions. I also provided cover to the A&E unit (a small eight beds unit in the same hospital). As a result, I gained invaluable experience managing various medical disorders, such as acute disorders (delirium, infections) and chronic conditions (such as diabetes, hypertension and other chronic disorders). I was also interested in managing mental health disorders in patients with psychosomatic symptoms.
